I acknowledge that hunting, all outdoor sports and activities as well as target shooting have inherent risks, hazards, and dangers for anyone, that cannot be eliminated, particularly in a wilderness environment. I UNDERSTAND THAT THESE RISKS, HAZARDS, AND DANGERS INCLUDE WITHOUT LIMITATION:

1. The risk of handling firearms and being near others that have firearms in their possession,
2. The risk of injury from ammunition and shot from other guns;
3. Inclement weather conditions;
4. The risk of injury from riding in a motor vehicle.

I understand the risks, hazards and dangers as described above and have had the opportunity to discuss them with \_\_\_\_\_(name of coach). I understand that these activities may require good physical conditioning and a degree of skill and knowledge. I believe I have that good physical conditioning and the degree of skill and knowledge necessary for me to engage in these activities safely. I understand that I have responsibilities. My participation in this activity is purely voluntary. No one is forcing me to participate and I elect to participate in spite of the risks. I AM VOLUNTARILY USING THE SERVICES OF THE LOWER PROVIDENCE ROD & GUN CLUB INC., THE LOWER PROVIDENCE ROD & GUN CLUB JR. TRAP TEAM WITH FULL KNOWLEDGE OF THE INHERENT RISKS, HAZARDS, AND DANGERS INVOLVED AND HEREBY ASSUME AND ACCEPT ANY AND ALL RISKS OF INJURY, PARALYSIS, OR DEATH.

For and in consideration of being allowed to participate, I for myself, my heirs, successors, executors, and subrogees, hereby KNOWINGLY AND INTENTIONALLY WAIVE AND RELEASE, INDEMNIFY AND HOLD HARMLESS THE LOWER PROVIDENCE ROD & GUN CLUB, INC., THE LOWER PROVIDENCE ROD & GUN CLUB JR TRAP TEAM, their directors, officers, agents, employee, and volunteers from and against any and all claims, actions, causes of action, liabilities, suits, expenses (including reasonable attorney's fees) which are related to arise out of, or are in any way connected with my participation in this activity including but not limited to, NEGLIGENCE of any kind or nature, whether foreseen or unforeseen, arising directly or indirectly out of and all damages, property damage, loss of use, illness (including but not limited to illness as a result of a communicable disease), bodily injury, mental anguish and/or emotional distress, and any other losses or damages, including paralysis and/or death, results from negligence of THE LOWER PROVIDENCE ROD & GUN CLUB INC., THE LOWER PROVIDENCE ROD & GUN CLUB JR. TRAP TEAM, their directors, officers, agents, employee, and volunteers or from some other cause. I, for myself, my heirs, my successors, executors, and subrogee, further agree not to sue

I acknowledge, covenant, and agree that **I HAVE READ THIS AGREEMENT**, and I **UNDERSTAND ITS TERMS**, and I am executing this agreement voluntarily, as a condition of participation of the Minor in **Team Activities** both on and off of the **Club Premises**, and/or entry upon and use of the **Club Premises** by the Minor I am sponsoring. **AS AN ADULT SPONSORING THE MINOR, I AGREE TO BE FULLY RESPONSIBLE FOR ALL ACTIONS AND/OR OMISSIONS OF THE MINOR, AND I HEREBY AGREE TO ASSUME, JOINTLY AND SEVERALLY, ALL OF THE DEFENSE, INDEMNIFICATION AND HOLD HARMLESS OBLIGATIONS NOTED ABOVE RELATED TO ALL ACTIONS AND/OR OMISSIONS OF THE MINOR.**
